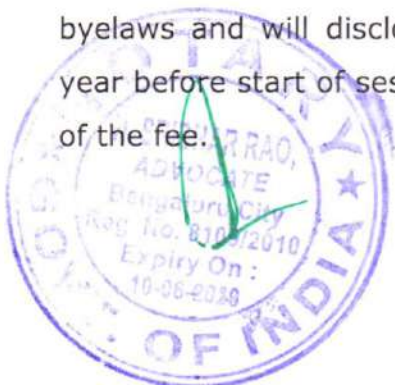
1. That **Karnataka Education Trust** is a registered Trust under the Section 4 of Indian Trust Act 1982.
